License Fees for Our Cats and Dogs

Licenses are renewed yearly and they expire on December 31st. The grace period for purchasing licenses is February 28th, after that date there is a \$10.00 late fee applied. You need to provide proof of a current Rabies vaccine, this disease is deadly and we want to keep our pets and families safe.

It is a misdemeanor for any person to violate any of the provisions of this Chapter. Each person convicted of a misdemeanor for a violation of any provisions of this Chapter for which a different penalty is not provided shall be punished by a fine of not less than one hundred fifty dollars (\$150.00) or more than five hundred dollars (\$500.00).



Permits are required for chickens. Please contact the County Sanitarian 406-222-4145 located in lower level of City County Complex.



All dogs that get left in yard for any length of time must have a dog house to escape the excessive weather conditions. They also need to have water provided. "Nuisance animal" means any animal that is off of the premises of the animal's owner creating a condition which endangers safety or health, is offensive to the senses of a reasonable person, or obstructs the free use of property, including, but not limited to:

- Causing injury or damage to property;
- Animal defecation which is not immediately removed from public or private property and properly disposed of by the owner or the person responsible for the animal;
- Cat urination;
- Hunting or killing wildlife, including birds;
- While the animal is in estrus (heat);
- When the animal is unvaccinated;
- When the animal is unaltered or unspayed; or
- When the animal tips over garbage cans or otherwise disperses garbage onto public or private property.

"Owner" means and includes any person owning, possessing, keeping, or harboring an animal or allowing the animal to remain on the person's residence. For purposes of this Chapter, anyone who feeds or otherwise attracts a stray or homeless animal to said person's residence shall be deemed to be the owner of said animal.

"Residence" means the dwelling place and surrounding property of one (1) family.

"Restraint" means controlled by a leash not longer than six (6) feet or within the enclosed portion of a motor vehicle.

"Running at large" means a dog, fowl, livestock, amphibian, reptile, or insect of the premises of the owner and not under the control of the owner or any other person either by leash or other physical means of control.



LEASH LAWS

Sacajawea Park is a NO DOGS POLICY this has always been that way. You may walk the perimeter of the Park as long as the dog has a leash on. With the exception of the following areas dogs must be leashed at all times when off your property.

OFF LEASH AREAS

Miles Park Band Shell area is leash free (except on special events that are Dog Free) includes the area of walking path up by the river. Please keep the dogs out of the Softball field as well as crossing in between the fields.

Mayors Landing is leash free . The road leading up to Mayors Landing is not part of the off leash zone

9th Street Water Park is leash free . Dogs must be leashed until arriving at the location.

Bozeman Trail Connector out by Star Addition is also leash free. Please use caution and be aware of rattlesnakes in the area.

Exercising of animals with any motorized vehicle anywhere in the city is not permitted.



Animals do not do well in the heat, a car can quickly become a oven. The surface of the asphalt as well as the back of pickup trucks and flat beds that are metal hold the heat and can severely burn the pads on the paws. Please cover the surface with something or leave your pet at home for the day.

Barking is a normal behavior for dogs and an important means of communication. They may bark when calling out to other dogs or respond to other barking dogs or when communicating with their human owners. Any noise, no matter how slight can stimulate a barking response for e.g. rustling leaves, a banging window or a knock at the front door/doorbell.

However, when dogs bark excessively this usually indicates an underlying issue and they can become a nuisance to their owners and the neighborhoods. Before you can successfully manage a barking problem you will need to determine the cause of the barking. Your neighbors may be able to tell you how often your dog barks in your absence.
