  - DISCUSS/APPROVE/DENY – APPROVE FUNDING MECHANISM FOR BRIDGE LOAN OR **GRANT TO LIVINGSTON SKATE PARK** – On 3/16 Pettit and Ebinger met with the City Manager and discussed the options for loaning money to the skate park. The option of making a good faith loan of \$65,000 to the skate park with either a 2 year or 3 year payback was discussed. Pettit presented the options to the board as a whole. Ebinger is in favor of a 2 year payback agreement. Pettit and Ames agreed that they are also in favor of a 2 year payback agreement. Derek Smith thanked the board for their support and said he believes the skate park committee will be able to pay the loan back in 2 years. Pettit called the question. Ebinger made a motion for the URA to make a "good faith loan" of \$65,000 to the McNair skate park with the conditions for the loan to be paid back in 2 years, with the understanding that the interest (equal to the bond interest rate) will be considered a grant from the URA and all payback money (including interest) will go to the URA to be used in the facade program. Ames seconded. All in favor, motion passed 4-0. (Pettit and Ebinger present, Ames via telephone conference and Hanser via text.)
