Subject: Livingston Downtown Plan – Budget Proposal

Below please find a budget proposal for funding a new Livingston Downtown Plan. As you all may know, the current plan (Urban Design Framework Master Plan) is nearly 20 years old.

A new downtown plan can be helpful to the community in a variety of ways. First, it can help vest current community members, city commissioners and staff in helping set the stage for future growth and change. A new plan would respond to current needs, particularly housing which the current plan does not address. A new plan would work together with the city's new growth policy, which was comprehensively revised last year, as well as the nearly completed active transportation plan. It is important that all city plans work in concert with one another, that they are periodically updated, and that they are reflective of our community's vision for the future. We want a downtown plan that allows our downtown to grow in a manner that protects our community heritage while ensuring the downtown is a place that is economically and socially vibrant. We need a plan that is used by our city, not one that sits on a shelf.

Since 2019, Park County Environmental Council has worked in partnership with the Park County Community Foundation and City of Livingston to help move forward on a new plan.

Accomplishments to date include:

- Reinstatement in the Montana Main Street Program 2019.
- Montana Main Street grant recipient for new downtown plan 2020.
- New Livingston Growth Policy 2021.
- Inventory of Space Utilization in Downtown Livingston 2021.
- MSU Community Design Center, Fall Studio project, downtown Livingston 2021.
