PROJECT TITLE: New Windows and Façade upgrades

PROJECT SUMMARY: The general exterior of 101 Main is in need of rehabilitation after years of substandard maintenance, neglect, and weathering typical of harsh Montana environment. Specifically, the 17 windows along the upper store are of particular concern and the flaked paint over brick is coming off. Although the windows were replaced some years ago, the installation and materials led to premature failure and blighted appearance, peeling paint etc. Our intention is to remove the paint and treat the brick and replace these (double hung) wood framed single glazed windows with modern aluminum framed energy efficient dual pane units that will last many decades with minimal maintenance. The total budget is \$130,000 and we are seeking a grant for half at \$65,000.

We have solicited a bid for the custom sized window units from Lake Glass in Bozeman MT as they have supplied similar windows to other restoration projects in Livingston.

STATEMENT OF CONDITION/NEED: The general exterior of 101 Main is in need of rehabilitation after years of substandard maintenance, neglect, and weathering typical of harsh Montana environment. Specifically, the 17 windows along the upper store are of particular concern and the flaked paint over brick is coming off.

PROJECT WORK PLAN: We have solicited a bid for the custom sized window units from Lake Glass in Bozeman MT as they have supplied similar windows to other restoration projects in Livingston. We have also submitted a bid from The Paint Factory in Bozeman for brick restoration. Lastly, we've included the site plan drawings.


Alley Elevation Scale 3/16" = 1'


Main Street Elevation






Second Level


